Proposed expansion of Severn Vale School

Dear all

We write on behalf on the Governing Body of Severn Vale School to consult with you regarding the School's proposal to increase its Published Admission Number (PAN) from 235 to 265 in September 2018.

The proposal for an increase in the Year 7 intake in September 2018 would not affect the size of the other year groups at that time. The school would increase in size year on year with an eventual capacity for 1325 students by 2022.

The proposal to increase the school's PAN is in response to the rising demand for places in the secondary sector in Gloucester and is part of the Local Authority's response to the Place Planning Strategy which clearly highlights the rising demand for places in the secondary sector in Gloucester.

The school will be holding an information drop in event between 6:00pm and 8:00pm at Severn Vale School on 8th February 2017. This will give you the opportunity to find out more about this proposal and to see plans of how the school's site will be developed to accommodate the additional numbers. Members of the Governing Body, the School's Leadership team, together with Officers from Gloucestershire County Council and members of the design team will be on hand to answer questions.

The consultation period will run from 3 February to 2 March 2017.
